- 3. No commission will be paid before the student has enrolled on their course.
- 4. Remuneration statements will be available via the portal from dates published at <u>www.cambridgeeducationgroup.com/about-us/agents-agreement.htm</u>.
- 5. If tuition fees are received after the cut-off date for calculation of commission (generally a week before the beginning of the statement production period) then the commission due would be included in the following term's statement.
- 6. New student headcount is subject to registration and continued enrolled status four weeks after the first term start date.
- 7. Commission for intermitters will be calculated based on their original first term start date.
- 8. Commission for King's College London programmes will be paid on total tuition fees subject to continued enrolled status four weeks after the start date.
